



# Projects for Humanity (P4H) Donor Privacy Policy

Projects for Humanity (“P4H”) respects the privacy of our donors. In order to better protect our donors’ privacy, we provide this notice explaining our online information practices and the choices you can make about the way your information is collected when you visit [www.projects4humanity.org](http://www.projects4humanity.org) (the “Website”).

## 1. Information We Collect and How We Use it

- a. In the course of using the Website, we may collect your name, email address, mailing address, telephone number, payment information for donations, and certain personal information when you sign up to be a volunteer. We may also aggregate non-personal information about how the Website is used. We may use IP addresses (which are not lined to personal individual of any individual user) to analyze trends, administer our website, track volume of usage, and gather broad demographic information for aggregate use only; this information helps us measure the number of visitors to various sections of this Website and to help make the Website more useful.
- b. P4H does not sell names or other personal information about our Website users and subscribers to our social media to mass marketers or any other entity, nor do we engage in exchanges of such information. We do not share donor information with other organizations. Online credit card donations are processed through a third party service provider and we do not retain, store, sell, or share any of your credit card or payment-related information.
- c. We protect our database by means of various technical and procedural measures, and we restrict access to your information by unauthorized persons. We require our third party service providers to comply with confidentiality requirements and to not use your personal information for marketing purposes without your consent.

## 2. Links to our Websites

- a. The Website may provide links to other websites. P4H is not responsible for the privacy or security practices of other websites or practices of other organizations and individuals. Your use of any linked website is solely at your own risk.

### **3. Anti-Spam Policy and Your Opt-Out Rights**
