We distributed 42 sewing machines, 99 livestocks, 22 small business (grocery stores), 13 motorized rickshaw, built 16 houses and 60 other livelihood supports in Bangladesh so that those family can earn money and lead their family self-sufficiently. This benefitted 260 families.
